FIREARMS APPLICATIONS

INSTRUCTIONS: Read and follow instructions completely. If your application is not completed correctly, you will be contacted and required to pick up your application to make the necessary corrections. **We recommend the applications and mental health form be completed on line at the Borough of Midland Park web site at: <http://www.midlandparknj.org/police-department.html>**

REFERENCES: Mailing addresses must be accurate & complete. Include ZIP codes and phone numbers. We will not correct improper addresses or ZIP codes. Do not use a family member as a reference.

INITIAL FIREARMS IDENTIFICATION CARD: (MUST BE 18 YEARS OLD)

- { } Each applicant must complete two (2) applications. Sign and date each of them
- { } Check off appropriate box on application form
- { } \$5.00 cash, check or money order made payable to the Borough of Midland Park
- { } Completed Mental Health form – must sign in the presence of a Midland Park Police Officer or records clerk
- { } **Once the completed applications are submitted, the applicant will receive a Contributor # for box 7. The form must be presented the fingerprinting agency. The applicant must follow the procedures for fees and appointments as instructed on the New Jersey Universal Fingerprint Form.**

*You may also apply for a pistol permit at this time, but you must be 21 years old for a pistol.

- { } Check off: Application to purchase a handgun and indicate the amount of permits requested.

REPLACEMENT FIREARMS ID CARD (Address Change, Lost, or Destroyed Card)

- { } Check off appropriate box on application.
 - * If your ID card has been lost, stolen, or destroyed, you are required to fill out a brief statement as to what you believe happened to your ID Card. (Statement form attached)
- { } Completed Mental Health form – must sign in the presence of a Midland Park Police Officer or records clerk
- { } You must surrender your initial Firearms ID card
- { } See attached form for instructions on completing online criminal background check (**Electronic 212A form**)

PERMIT TO PURCHASE HANDGUN (MUST BE 21 YEARS OLD) – For when you already possess a Firearms ID card

- { } Each applicant must complete two (2) applications. Sign and date each of them
- { } Completed Mental Health form – must sign in the presence of a Midland Park Police Officer or records clerk
- { } \$2.00 cash, check, or money order payable to the Borough of Midland Park for each pistol permit requested.
- { } **Once the completed applications are submitted the applicant will be provided with instructions on completing the online criminal background check (Electronic 212A form)**

*Use this sheet as a check-off form and return with application packet. This will assist you in making sure your application is completed properly. Make sure you have signed and dated the application where required.
